NHS eProcurement strategy


- Sets out how we will establish both GS1 & PEPPOL data standards across the healthcare market
- Our ambition is to drive operational efficiency, improve management reporting and to enable data capture technology at the point of care
 - We will work with the HSCIC to build National Infrastructure.
 - Work collaboratively with Suppliers, Acute Hospitals and Technology Providers to establish integration to the Infrastructure.

Mandate

- NHS Terms and Conditions of Contract (August 2013)
 - suppliers must place product data in GS1 datapool
- NHS Standard Contract (2014-15)
 - providers must comply with eProcurement guidance


GS1 coding standard



Key points:

- GS1 compliant master data throughout supply chain
- master data in near real time synchronisation
- single national Product Information Management system

PEPPOL messaging standard



Key points:

- any hospital purchase order processing system
- any PEPPOL access point
- any supplier sales order processing system

Benefits to suppliers

- A single data source for product information available to all NHS customers
- Reduced transaction costs due to fewer price based invoice queries and reduced supply chain disputes by provision of accurate and timely order, delivery and invoice information
- Greater efficiency and visibility of product throughout the supply chain reducing wastage, lowering the costs of product recall and enabling compliance with forthcoming European anti-counterfeiting and traceability legislation
- Reduced data management costs associated with rekeying, poor transcription, maintenance and cleansing and synchronising with supply partners for product catalogues and location identification
- Saving in time and increased efficiency and reliability in production, storage, picking, shipping and reporting through the use of barcode scanning

Benefits to suppliers

- Connect once to a PEPPOL Access Point to reach all NHS providers
- Freedom to chose your own Access Point (AP) provider with no compulsion to engage with the AP providers of your clients
- Use of a single eProcurement document standard to do business with all public sector clients across the UK healthcare sector with growing adoption in other EU countries
- Usability of PEPPOL in both B2G and B2B transactions

- We will gather feedback from stakeholders where industry responses differ to our proposed approach



CLASSIFICATION SYSTEMS


The Department of Health (DH) commissioned GS1 to examine options for product classification for the healthcare system, which resulted in the following recommendations:


- 1. All products in the NHS datapool should be classified by a GS1 Global Product Classification (GPC) code
- 2. Additionally all medical devices should be classified by a Global Medical Device Nomenclature (GMDN) code
- 3. Additionally all medicines should be classified by a SNOMED CT code
- 4. NHS-eClass codes should be used during the transition to the above classification systems.
 - All medical devices with NHS-eClass classification codes should be transitioned to GMDN
 - Any medicines with NHS-eClass classification codes should transition to SNOMED CT
 - All other products with NHS-eClass classification codes should transition to GPC
- 5. To facilitate this transition, the DH will work with GS1 and the GS1 Global Standards Management Process (GSMP) to extend GPC to cover any product categories that are not adequately covered by the above classification systems


